Gift Aid declaration

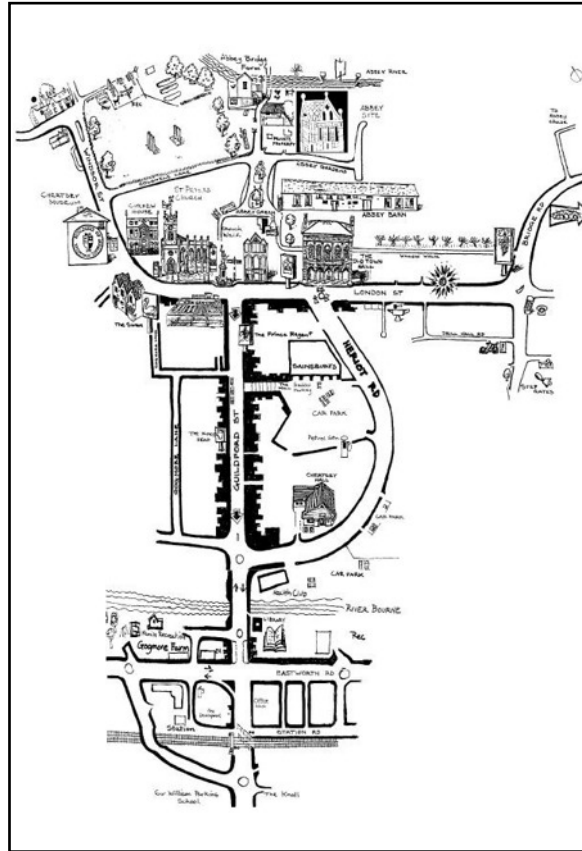

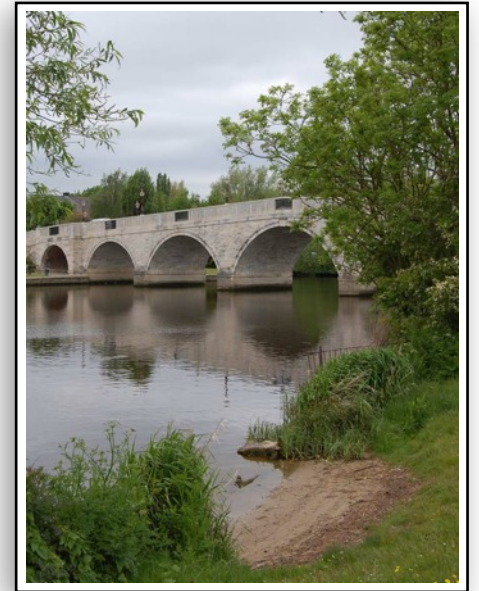

We were formed in 1960 and some of our achievements so far include:

- ✓ initiating the establishment of the Chertsey conservation area and producing guidelines with Runnymede Borough Council for its protection
- ✓ encouraging the Council to set up Chertsey Museum
- ✓ helping them restore and preserve the remaining part of the Abbey walls and create the Memorial garden
- ✓ resisting the demolition and encouraging the restoration of historic buildings
- ✓ instigating the placing of the statue of Charles James Fox
- ✓ making representations at Public Enquiries on local and County Structure Plans
- ✓ restoring the Office of Town Crier and providing ongoing sponsorship
- ✓ project managing the replacement flagpole on St. Peter's Church
- ✓ resisting gravel raising and the erosion of the local Green Belt
- ✓ providing the Christmas Lights for Chertsey town centre

## What we do

During the winter we hold monthly meetings, usually at St. Peter's Church Hall, with interesting speakers on varied subjects ranging from wildlife to historic buildings. We also organise the annual Town Forum and visits to Chertsey Museum.

Other social events take place, such as

- ☞ lighting the Beacon on St Ann's Hill for the Queen's Jubilee and the Magna Carta 800th celebrations
- ☞ running a stall at the Black Cherry Fair, Chertsey Agricultural Show and similar events



The committee meets each month and maintains a continuous representation to the Borough and County Councils, Government departments and MPs on topics affecting the town and its environs. We also liaise with other groups and have our own historic archive.

We are affiliated to many national and local groups, such as The Georgian Group, CPRE and the British Association for Local History, who share our aims.

Members are kept up-to-date with our activities through illustrated newsletters and our website, and the minutes of the committee meetings are filed in the Chertsey Library each month.
